





Did you know...



Since 2001, AAUW Santa Cruz Branch has distributed a total of 17 monetary awards to UCSC re-entry women averaging \$750 per scholarship. The number of gifts to the fund plus the market value totals over \$43,000 currently managed in our UCSC endowment.

Background on some of the endowment donations: Helen S. Gibson passed away in Santa Cruz, CA on September 25, 2007, at the age of 79. Helen had lived in Santa Cruz County for 25 years. Formerly she was a social worker serving the blind for the City & County of San Francisco for 25 years. She was a longtime active member of American Association of University Women, with a scholarship named in her behalf due to her years of charitable work.

We have received applications from many very talented young women throughout Santa Cruz County. It is always difficult to choose the best among so many outstanding 7th grade girls. We look forward to announcing their names soon, but are still in the selection process. Thanks to **Elena Cohen** who donated recently to this fine program.

Our branch has been involved with Tech Trek since it began in 1998 and many of you have both contributed to it monetarily and with the program itself. Jane Amaral and Jeanne Jorgensen have both been managing the details of the program for 6-8 years and would like to see others step up and enjoy the involvement with the schools, girls and camp. The selection process is handled online which has streamlined the whole program. It is a very rewarding activity and we encourage your involvement. Training and mentoring will be provided! Equal Pay Day 2015 is a wrap!

As you know, Equal Pay Day is the symbolic day when average women's wages catch up with men's from the previous year. Each year, AAUW marks the day with actions and events on college campuses, at state capitols, in the community, and on Capitol Hill. Equal Pay Day provides a great opportunity to increase public understanding of the gender pay gap and urge action to close the gap once and for all.

As you can imagine, it was a busy and inspiring day. I kicked it off at the Department of Labor, where Secretary Tom Perez hosted a conversation with House Minority Leader Nancy Pelosi (D-CA). From there I moved on to the Capitol where I joined allies and elected officials, including Sen. Elizabeth Warren (D-MA), Rep. Rosa DeLauro (D-CT), and Rep. Barbara Mikulski (D-MD), in calling for passage of the Paycheck Fairness Act (watch here). I was so proud to speak on behalf of AAUW at this press event, and was moved by the powerful stories from workers who have experienced pay discrimination as well as employers who are committed to paying their employees fairly. To cap-off the day, I attended AAUW's somewhat soggy but still enthusiastic and well-attended (un)happy hour outside our national headquarters building. The weather might not have cooperated, but the crowd was more than ready to demand fair pay.

Throughout the day, I heard about wonderful AAUW activities across the country. AAUW members and leaders once again produced some great events and activities. We were at five state capitols, more than 50 campuses, and led rallies and press conferences in a number of cities (these are just the reported activities! Have you told us about your event?). We placed letters to the editor and got proclamations from local governments nationwide. Social media was abuzz on Tuesday, and #EqualPayNow was a trending topic in DC with prominent participants like Lilly Ledbetter, Patricia Arquette, Valerie Jarrett, many elected officials, and even President Barack Obama! AAUW's #EqualPayNow tweets made almost 8 million impressions and were re-tweeted nearly 1,300 times. The AAUW Action Fund Capitol Hill Lobby Corps built upon the momentum of Equal Pay Day and lobbied the Senate on the Paycheck Fairness Act on Thursday, visiting more than 50 offices. And last but certainly not least. AAUW CEO Linda D. Hallman, CAE penned an op ed with Sonya Syngal of Gap, Inc. urging employers to follow the Gap's example in examining its wages and ensuring equal pay for equal work.

I can feel the equal pay energy and momentum. Because of all your work, together we created a successful week of advocacy and visibility for AAUW at the local, state, national, and even international level. For example, last week Tokyo hosted its first-ever Equal Pay Day rally. While we all look forward to the day when Equal Pay Day is ancient history, until then it's critical that we keep up the fight beyond Equal Pay Day until everyone is paid fairly.

AAUW Cheer of the Week On Tuesday, April 14, President Obama issued a Presidential Proclamation declaring the date National Equal Pay Day. He spoke about the Lilly Ledbetter Fair Pay Act and his creation of the National Equal Pay Task Force, which focuses on violations of equal pay laws. He also reiterated the critical role of Congress in this effort and urged them to pass the Paycheck Fairness Act. Broadening his call to advocacy, the President asked "all Americans to recognize the full value of women's skills and their significant contributions to the labor force, acknowledge the injustice of wage inequality, and join efforts to achieve equal pay."

AAUW Jeer of the Week A recent opinion piece received attention this week for calling Equal Pay Day a myth. Some pundits and organizations continue to maintain that it's simply women's choices that account for the wage gap. The article does acknowledge that a wage gap persists and even hints that it may be a result of gender discrimination. Exactly our point. As Lisa Maatz, vice president of government relations, says, "the pay gap is not myth. It is math." Check out AAUW's The Simple Truth and learn the facts about the gender pay gap.



Celebrate Lilly and Urge Congress to Pass the Paycheck Fairness Act!

Lilly Ledbetter took a stand when she learned that she'd long been receiving a lower salary than her male counterparts were. She brought her pay discrimination case to the Supreme Court and to Congress, and her story spurred on the movement for equal pay. This year her 77th birthday, on April 14, falls on Equal Pay Day — the symbolic day when women's earnings finally catch up to men's earnings from the previous year. The very latest figures show that women are paid on average 78 cents to the dollar paid to their male peers. That's just a penny more than where the statistic has been stuck for a decade.

Celebrate Lilly's birthday this April by telling Congress to close the pay gap and pass the Paycheck Fairness Act. Tell them that when it comes to wages, women deserve better!

Fair pay champions in the House and Senate have reintroduced the Paycheck Fairness Act, one of AAUW's top priorities for the 114th Congress. You can be a critical part of passing the Paycheck Fairness Act by urging your members of Congress to be co-sponsors. Take action today! The more co-sponsors we have, the better chance we have of getting the attention necessary to move this bill.

Ask your members of Congress to co-sponsor the Paycheck Fairness Act today!

All over the country, at the state and city level, the demand for equal pay is growing. Members of Congress need to step up and make change for ALL families by supporting legislation such as the Paycheck Fairness Act - because if Congress doesn't act, the gender pay gap won't close in our lifetimes.

Let that sink in: At the recent rate of progress, the gap won't fully close for another 124 years, until 2139!
