Enter campus through UCSC's main entrance at the intersection of streets Bay and High. As you continue northbound on Coolidge Drive you will encounter two traffic signals. One mile farther, Coolidge bends westbound and becomes McLaughlin Drive. On McLaughlin you will stop at traffic signs at Hagar Drive and Chinquapin Road. I look forward to seeing you at the Gala. Remember, do your part for water conservation.



Local Scholarships News

Approximately 45 members and guests dined out for a good cause on February 10th. Shadowbrook gave Local Scholars Fund 33 1/3% of the evening's expenditures which added up to \$500.00! That was nearly \$100 more than we received last year. Everyone seemed to have a good time and we are all looking forward to next year's festivities.







AAUW (Watsonville and Santa Cruz) has been supporting Cabrillo students since 1986, contributing over \$81,000. Since then \$64,349 has been awarded in scholarships to students. And through the permanent endowments we have established at Cabrillo, we can count on at least \$2,250 awarded annually through our permanent endowments in perpetuity.

AAUW Santa Cruz

The first gift received from AAUW Santa Cruz was 7/1/1989 and we have received a total of \$31,315.

AAUW Watsonville

The first gift received from AAUW Watsonville was 10/27/1986 and we have received a total of \$50,045.

AAUW Santa Cruz and AAUW Watsonville have both established permanent endowed scholarships with their donations. These endowed funds are permanent, where the corpus stays intact, and only the earnings (4%), are awarded in scholarships each year. The following lists the historical gift value (amount donated to the endowment fund) for each endowment:

- AAUW Santa Cruz Branch in memory of Carol Symons: \$15,000 historical gift value
- AAUW Watsonville Endowed Scholarship: \$21,472.33 historical gift value
- AAUW Watsonville Congdon, Dickson, Smith Endowed Scholarship: \$20,000 historical gift value
- Our records for tracking the amount in scholarship awards only go back to 2000. The following lists the amount in scholarships that have been awarded since the year 2000 from AAUW Santa Cruz and AAUW Watsonville:
 - AAUW Santa Cruz Nonendowed: \$21,248.63 total allocated from donations received annually
- AAUW Santa Cruz Endowed: \$17,532.52 total allocated from the earnings of the endowment
- AAUW Watsonville Nonendowed: \$1,195 total allocated from donations received annually
- AAUW Watsonville Endowed: \$21,472.33 total allocated from the earnings of the endowment
- AAUW Watsonville Congdon, Dickson, Smith Endowed Scholarship: \$2,902 total allocated from the earnings of the endowment.

The IBC luncheon on Saturday February 28th at Seaside was definitely in the spirit of Tech Trek. An "opportunity" drawing was held & two winners shared 50% (\$92.00 each) while Tech Trek received \$184.00. This money will go to enhance the camp rather than towards any camperships. Attendees heard from Drs. Jennifer Rhatigan and Claudia Luhrs, women who have excelled in the STEM area. While we all enjoyed hearing them, we agreed that the target audience is young middle and high school girls and there were many good suggestions on how that can happen. Thanks to recent contributors to our Tech Trek fund: Pat Clark, Joan Brown, Pat Nellany and Barbara Lewis. Stop the Budget Sequester

March 9, 2015

It's been one month since President Barack Obama kicked off the federal budget season by releasing his budget proposal for Fiscal Year 2016 (which begins in October). It's a \$4 trillion proposal that would finally end the across-the-board spending cuts known as sequestration.

The big question is what will Congress do with this proposal? Will Congress end sequestration as well, before the devastating cuts hit more programs that serve women and families? That's where you come in!

If Congress doesn't act, the sequester will continue unabated throughout the next decade. This is no way to write a budget and make decisions about meeting our country's priorities. And we need to make sure Congress knows this.

<u>Take action today: Tell your members of Congress to stop the budget sequester!</u> Doing so will allow us to end the cuts to vital programs that help women and families and instead make the investments our country needs.

Sequestration has taken a toll on our communities. The last time sequestration was in effect, school districts across the country lost billions of dollars in federal education funding. That meant larger class sizes, elimination of after-school programs, fewer teachers, and fewer resources for kids who need the most help.

We also saw cuts to other important programs such as food assistance programs for women and children, cancer screenings, services for domestic violence survivors, and federal funding for low-income schools.

If Congress allows sequestration to return, the damage is expected to grow each year that the across-the-board cuts continue. Sequestration was intended to be a short-term measure, not a permanent method of setting our federal budget priorities. Our Constitution makes it clear that one of Congress' main duties is to pass a budget. It's time Congress did that.

In the coming weeks, Congress will start considering its proposal for the FY16 budget - so we need to make our voices heard now. <u>Tell your members of Congress: Pass a real budget</u>. Stop the sequester.

Domestic spending has already been significantly cut to reduce the deficit. It's time to end the sequester and consider investments in non-defense spending, on the resources and programs that are known to help women, working families, and our economy. We can do this in a way that continues providing financial support to our military and veterans, too.

Can you take two minutes to ask your member of Congress to end sequestration in the budget? We need to raise our voices now, while Congress is beginning its job of writing the budget!



When Marie Curie Needed Radium, We Obliged

Did you know that in 1920, the <u>Association of Collegiate Alumnae</u> (the predecessor to AAUW) helped raise money to purchase a gram of radium for Marie Curie? It was an effort led by Marie Meloney, a journalist and editor of *The Delineator* women's magazine. Meloney had interviewed Curie. During their discussion, the scientist stated she was in short supply of radium, an element that she had discovered. Meloney asked, "If you had the whole world to choose from, what would you take?" Curie replied, "I need a gram of radium to continue my research, but I cannot buy it; radium is too dear for me."


Meloney left the interview determined to make Curie's wish come true. Meloney organized a group of women in the United States and formed the Marie Curie Radium Fund. The Association of Collegiate Alumnae was an active participant in this effort. Within the ACA, the International Federation of University Women American Committee took on the project. This committee consisted of 35 women. Many prominent leaders loomed large in the group: Virginia Gildersleeve, Ada Comstock, Aurelia Reinhardt, Marion Park, Mary Woolley, and Meta Glass. Several committee members went on to become AAUW presidents.

In 1921, Curie visited the United States, along with her two daughters, to receive her gift of radium. Curie toured the country, and there was much fanfare and publicity associated with her visit. While in New York, the AAUW New York City (NY) Branch organized an event in her honor at Carnegie Hall. She then traveled to Washington, D.C., and visited the White House, where President Warren Harding presented her with the gram of radium in a lead-lined box.



Interesting Facts:

 Marie Curie is one of only four people to win the Nobel Prize in Science two times, once for discovering effects of radioactivity; once for isolating radium.



At the time, a gram of radium cost \$100,000. The Marie Curie Radium Fund was so successful that it raised an additional \$56,413.54. After Curie died in 1934, the money was passed to her daughter, Irene Joliot-Curie, who at the time was continuing her mother's research.

The funds eventually went into a trust managed by a bank, and the ownership of the money was called into question. AAUW had to fight the case in court in order to secure the money for a cause related to its original purpose. After the court case, the bank granted the funds to AAUW to use for the Marie Curie Fellowship, which was first awarded in 1963, to support a French or American woman studying chemistry, physics, or radiology.

The AAUW archives contain historical records documenting AAUW's relationship with Curie, including a spectacular program from the Carnegie Hall event suggesting the grandeur and pageantry associated with Curie's visit to America. Although the program is a hidden gem in the collection, the larger picture remains more important. AAUW was not only involved with Curie's work when she was alive but also continued to serve as the steward of her money long after the fanfare of her visit had faded.
