Have you marked your calendar? January 18th, End Human Trafficking, Twin Lakes Church, 11:30-3PM. A comprehensive program detailing problems and solutions for this continuing disgrace in our modern world. Light refreshments and an opportunity drawing will take place. Carol De Lauder, representing Soroptimist, was able to distribute over 50 of our "stickers" to the northern California conference. She reports that a judge took 25 to post in the San Francisco courthouse as well as all attending delegates receiving flyers and stickers.

Our national political news makes it easy to forget the continuing acts of slavery throughout the world. Angelica Carpenter is the author of the book Born Criminal: Matilda Joslyn Gage, Radical Feminist. She will tell us all about Matilda Joslyn Gage (1826-1898) who was a feminist leader, writer, conference organizer and specialist in civil disobedience. She changed the course of history. For decades she worked with Susan B. Anthony and Elizabeth Cady Stanton, but she was more liberal than they were, fighting for equal rights not dependent on sex, race, class, or creed. Gage also served as a writing mentor to her son-in-law, L. Frank Baum, who later wrote The Wonderful Wizard of Oz, about a strong American heroine. Carpenter explores Gage's life, including her rise and fall within the women's movement she helped build.

Tech Trek News

We met as a Tech Trek Group October 14th and reviewed the September luncheon. It appears to have been generally well received. The table color idea seems to have been a good option again this year with members seated by badge color. If any of you have other luncheon info, we would love to have it so we can constructively include if for next year.

We got good pre news coverage for the luncheon in the local papers. As you may have seen, we got excellent followup with the Times publication on October 15 issue: a picture on the front page with a nice additional article on the inside. Though I sent the same info to all the other papers, this was the only group who printed it.

Now on to 2020 Tech Trek Planning!

Thrilled to have new committee members. Lorraine Margon and Sharon Bush as well as returning member Joan Rider to bring new ideas and help to our TT group (Jane Amaral, Susan Chollar, Kit Hein and me).

At our first meeting of Tech Trek 2020 we reviewed the Teacher Survey that was sent out after our Tech Trek selection process last year. Results have helped us with timing teacher requests so that we can get the best responses.

Last year National made some very big changes to reporting that made it more time consuming for teacher responses and added some confusion. We will simplify the material we send out to better engage the teachers.

Teacher and school contacts are being validated. Teacher letters and TT brochures are being reviewed and updated. We will include them in a package that will go out to the teacher contacts at each County school this month. We will follow up with the teachers with a second letter January 13.

We have sent the WISE SIS info for the first Saturday project (November 23) to the teachers who nominated the 2019 girls, and the 2019 girls. We hope that some, or all of them will continue on with STEM programs offered.

We continue to research other fund raising options. If any of you have contacts at any tech (or other companies) who might be interested in sponsoring a girl to go to Camp Hopper, please let me know. Our members are very generous, but we hope to be able to supplement their generosity with outside money. Grant writing, anyone?????

Governor Signs 14 AAUW-Supported Bills Into Law

The 2018-19 legislative season has come to a close, and by October 13, 2019 Governor Newsom signed 870 bills out of the 1,042 bills that were presented to him. Among the most significant of these were fourteen bills which will become law due to the advocacy and research support offered by AAUW-CA:

AB 9 - Extends the time for filing harassment and discrimination claims under California's Fair Employment and Housing Act (FEHA) from 2 to 3 years, allowing survivors additional time to seek redress.

AB 51 - Prohibits an employer from requiring an employee to waive any right for a labor code violation as a condition of employment, continued employment or receipt of employment benefits.

AB 59 - Directs county elections officials to consider a vote center location on a public or private university with the intent to increase youth voter turnout.

AB 170 - Closes a gap in the law to ensure that employers do not resort to subcontractor agreements for purposes of avoiding liability for sexual harassment claims.

AB 218 - Increases the civil statute of limitations period for commencement of a sexual assault cause of action. This will give sexual assault survivors sufficient time to access civil remedies.

AB 381 - Ensures that prevention and bystander intervention outreach on dating violence information is made available to incoming students during orientation.

AB 543 - Ensures that all 9th through 12th grade students receive a written policy on sexual harassment information during orientation. AAUW's report "Schools Are Still Underreporting Sexual Harassment and Assault" was critical in helping support the legislative analyses for AB 543.

AB 749 - Prohibits the use of "no rehire" clauses in settlement agreements that broadly restrict future employment opportunities for workers settling a sexual harassment or other claims.

AB 809 - Mandates that public postsecondary institutions provide notice to students to ensure that pregnant and student parents are aware of their Title IX rights.

AB 922 - Allows a woman providing human oocytes for research to be compensated for her time, discomfort, and inconvenience in the same manner as other research subjects.

SB 24 - Increases access to reproductive health services for students at public universities and colleges by providing medication abortion at student health centers.

SB 142 - Requires employers to have a written lactation policy and lactation spaces that meet minimum requirements for lactating workers. While existing law requires employers to provide parents with the time and space to express breastmilk, SB 142 places specific guidelines to ensure that parents are sufficiently protected in the workplace.


